Today's Gospel reading is therefore poignant when Jesus says "I will not leave you as orphans." (John 14: 18). My wife, my boss, my brothers and sisters and


my church may have abandoned me but Jesus hasn't. In our gospel reading from John 14 Jesus makes three promises.

- Jesus promises he will not leave us as orphans.
- Jesus promises that the Father will send us His Spirit.
- Jesus promises that God the Father and God the Son will be at home with us also.



"I will not leave you as orphans; I will come to you. 19 Before long, the world will not see me anymore, but you will see me. Because I live, you also will live. 20 On that day you will realize that I am in my Father, and you are in me, and I am in you." (John 14: 18-20)

With great insight, Michael K Marsh observes, "I will not leave you orphaned." At some point we all want or even need to hear these words. They speak directly to some of our greatest fears and challenges; abandonment and isolation, loneliness, vulnerability. They remind us that we are not destined to walk this earth without an identity or direction. We do not stand


### New Birth



### Experts Urge Trump Admin. to Reconsider Abortion Drug Approval after Troubling New Research

A major study just revealed that the abortion drug mifepristone is far more dangerous than U.S. health agencies have admitted, prompting calls for President Donald Trump's Food and Drug Administration (FDA) to reinstate more stringent safeguards surrounding the drug's prescription and use, reinvestigate the health risks, and if warranted, reconsider its approval altogether. The Ethics and Public Policy Center (EPPC) released its report Monday, revealing that the rate of serious adverse complications associated with mifepristone is at least 22 times higher than the 0.5% touted by the FDA.

In a letter to FDA Commissioner Marty Makary, Senator Josh Haw-

ley (R-Mo.) joined the EPPC in demanding that the guidelines for administering mifepristone originally in place when the FDA approved the drug in 2000 be reinstated. "An alarming new study has revealed that the safety risk of the chemical abortion drug, mifepristone, are far greater than the FDA currently acknowledges," Hawley wrote. He continued, "I urge you to follow this new data and take all appropriate action to restore critical safeguards on the use of mifepristone. The health

and safety of American women depend on it." The senator concluded, "The time to act is now. It is time to revisit and restore the FDA's longstanding safety measures governing mifepristone."

Makary pledged last week to review new data regarding the safety of mifepristone, although he had not made a similar pledge when pressed by Hawley on the issue during his confirmation hearing before the Senate. Health and Human Services (HHS) Secretary Robert F. Kennedy Jr. had previously told Republican senators that he plans to "study the safety of mifepristone" and implement policies consistent with the president's position on the abortion drug. Kennedy said that the president "has not yet taken a stand on how to regulate it. Whatever he does, I will implement those policies."

In comments to The Washington Stand, Mary Szoch, director of the Center for Human Dignity at Family Research Council, said, "I am encouraged to know that FDA Commissioner Makary will remain true to his roots as a scientist and examine all of the data on mifepristone. The newest data shows one in 10 women has a serious adverse event following the use of mifepristone." She added, "I look forward to seeing the steps Director Makary will take in light of how dangerous this drug is for women."

Regarding the results of the EPPC study, Szoch stated, "The FDA has never thoroughly investigated the impact of mifepristone on all women." Noting the high rate of serious complications associated with mifepristone — more than one in nine women — she continued, "That number doesn't even begin to touch the number of women who have serious psychological issues after seeing their clearly recognizable unborn baby dead in the toilet as the result of a mifepristone abortion. The FDA must re-examine mifepristone and revoke its approval."

EPPC President Ryan Anderson, who co-authored the study, appeared on Monday night's "Washington Watch" to discuss his findings. He clarified, "The major takeaway here is that it's a 22-times-higher rate of serious adverse events for women who take the chemical abortion drug than what the FDA claims on the label." He continued, "Why do we see such poor outcomes? Both the Obama and the Biden administrations got rid of almost all of the major safety protections that the FDA originally required when they approved of the pill. So what we're calling on the Trump FDA to do is ... reinstate those original safety provisions."

Anderson also noted that, since the FDA has removed the requirement that mifepristone must be prescribed by a physician and dispensed and consumed in the physician's office, the abortion drug has been increasingly ordered online or via "telehealth mail order" and has even been shipped across state lines, including into states with strong pro-life laws in place. He explained that "many blue states" are "mailing the abortion pill across state lines."

Noting that the president has previously averred that the issue of abortion ought to be left to the states, Anderson continued, "Well, you can't leave it to the states if California is mailing abortion pills

to the other 49 states. You can't make America healthy again if you have a 10.9% rate of serious adverse events. And you can't undo all the stupid things Biden and Obama did unless you also undo what they did to the abortion pill. So that's what we're calling on the Trump FDA to do here."

Also on Monday night's episode of "Washington Watch," Dr. Donna Harrison, director of research for the American Association of Pro-Life Obstetricians and Gynecolo-

gists, said that her experience as an obstetrician/gynecologist confirms the EPPC study's findings. She explained that doctors "across the country are seeing similar kinds of things in the [emergency room], seeing women with hemorrhages, women with tissue left inside, women who have ectopic pregnancies that never should have gotten the abortion pill at all. And they got it because they never had an in-patient visit, they never had an ultrasound," because the FDA does not require it.

Harrison also explained that the FDA based its guidelines on clinical studies, which do not provide accurate data that corresponds to how the abortion drug is administered and used in the real world, especially without stringent safeguards in place. "Clinical trials are done under very controlled circumstances," Harrison said. She noted that women who participated in these clinical trials had ultrasound results, were tested for ectopic pregnancies, were within a certain gestational timeframe, and were excluded from the trial if they did not meet specific criteria. She said, "So these trials sought out healthy women where their gestational age, the dating of the pregnancy, is perfectly known. And then they're followed very, very, very carefully. That's not what happens in the real world."

Harrison detailed, "In the real world, Sally Smith, who may be 14, gets online, gives her gift credit card, and gets mailed mifeprex [the brand name for mifepristone]. She has no idea how far along she is. She may think that she's eight weeks. And I've seen cases where women were told, 'Oh, you're eight weeks along,' and they take the mifeprex and they deliver a 22-week baby who could have survived if that baby had been delivered under the right circumstances. It's this kind of horrendous care..."

Anderson also criticized the FDA's handling of the dangers of mifepristone. "[W]hat we saw in the Obama years and now, most recently, from the Biden administration, it was clearly politicized medicine to get rid of these original safety provisions," Anderson continued. He noted that regulations such as requiring multiple in-person physician visits, requiring a physician to prescribe mifepristone, requiring that the abortion drug be dispensed and consumed in the physician's office, requiring a follow-up appointment, and requiring adverse complications be reported were eliminated by the Obama and Biden administrations. Anderson stated, "This isn't looking out for the best interest of women. Certainly not looking out for the best interest of their unborn children."

In May of 1946, a newborn baby girl was found in a paper milk carton inside the door of the women's dormitory of Moody Bible Institute in Chicago. Because there was no protestant, evangelical, Christian agency to provide services for this newborn, "Baby Isabella" was placed in temporary foster care. Afterwards, a committee consisting of the judge, lay persons, and ministers gathered to consider the matter of establishing an evangelical Christian agency. By obtaining the sponsorship of the National Association of Evangelicals, raising \$5,000, and hiring a licensed social worker, the Evangelical Child & Family Agency opened its doors on May 1, 1950, in Wheaton, Illinois, and the Wisconsin office was opened on May 1, 1984.

In addition to their Pregnancy Support Services, ECFA assists Christian families with adoption placement. As an early agency letter states: "The Agency...places children directly in homes of fine Christian character where there is opportunity to grow up not only physically and mentally, but, above all, Spiritually." ECFA provides information on the adoption process, home studies, postplacement/adoption visits, and adoption training, along with providing a network of adoptive family support. ECFA can place children in forever homes through domestic, interstate, private, international, and embryo adoptions.

According to American Adoptions website, some sources estimate that there are about two million couples currently waiting to adopt in the United States — which means there are as many as 36 waiting families for every one child who is placed for adoption. There are thousands upon thousands of loving couples desiring to adopt a child into a caring, loving home.

To gain a little more insight into the Agency, I conducted a short interview with Dorinne Geldon, who has been working with the Agency as the Adoption Social Worker for 34 years.

Dorinne: "I absolutely love the mission, staff, and heart of ECFA, and everything it stands for. It's just an amazing agency, and I feel privileged to work there."

**Interviewer:** What is the mission and heart of ECFA?

Dorinne: "To affirm life and come alongside mothers, couples, and families who find themselves in crisis pregnancies or at a point in their lives where they're not ready to raise a child. Our Pregnancy Support staff come alongside the pregnant mother and help her with tangible goods like diapers, clothes, etc., as well as parenting tools and curriculum if she chooses to parent. Staff can work with the mom for up to six months after birth if she chooses to parent, or up to 12 months after birth if she decides to place. If she decides to place her child, her worker will "hold her hand" during the entire process, from being educated about adoption through choosing a family to raise her child and navigating what that relationship might look like with the adoptive family. In my area of adoption, our mission is to serve families who many times have been through a lot of difficult journeys with infertility and are unable to have their own biological children, or those who want to help an orphan or expand their family through adoption

for many different reasons. On my end, I provide home studies, post-placement services, and support to my adoptive families. I will also help families navigate what a healthy relationship would look like with the placing mom or family, or in the case of international adoption, assist in the transition of a child into a family."

**Interviewer:** Why should someone support ECFA?

Dorinne: "Because we are the hands and feet of Jesus in carrying out his mission of caring for orphans, the unborn, and those finding themselves in difficult situations who need support. Orphans are dear to the Lord's heart, lost people are dear to His heart, and children are dear to His heart. The staff loves the Lord, and we pray for our families and clients weekly. We love serving families. We provide free pregnancy support services to our clients and are not funded in any way federally or by the State, so we are fully supported by our wonderful donors."

Greeting from the Netherlands! By the time you receive this newsletter, I will have just completed a two-day Discovering Daniel conference in Veenendaal. Sunday night through Monday marked a very special celebration for Israel. Yom Yerushalayim, or Jerusalem Day, has been an annual event for the past 57 years marking the reunification of Israel following the Six-Day War of 1967. Egypt, Syria, Jordan, and Iraq had been preparing to launch a massive invasion into Israel, when, on June 5, 1967, Prime Minister Levi Eshkol and the government decided to launch a preemptive

The disciples were wondering how they are going to make it without him. Jesus knows they won't. So, Jesus promises, "I will not leave you as orphans; I will come to you."

But if Jesus was about to leave them, to be crucified, be raised from the dead and then ascend to heaven, how would he come to them? We believe that one day Jesus will return personally, but that is not what he promises here. The first promise is that Jesus will not leave us as orphans.

### 2. The Promise of the Holy Spirit.

"If you love me, keep my commands. 16 And I will ask the Father, and he will give you another advocate to help you and be with you forever— 17 the Spirit of truth. The world cannot accept him, because it neither sees him nor knows him. But you know him, for he lives with you and will be in you. (John 14: 15-17)

Jesus says, verse 16, he will ask the Father to send another Advocate. The Holy Spirit. The word is "parakleetos" in Greek which is difficult to translate into English hence some translations describe him as the Counsellor, Comforter, or Helper. The word is a combination of 'para' meaning beside and 'kaleoo' meaning 'I call'. So literally, 'one called alongside to help'. It was sometimes used as a legal term for a defense lawyer, an advocate. The word "another" is also significant, 'allos', means another of the same kind (that is a person just like Jesus). "I will ask the Father and He will give you another Advocate . . . "

Jesus then says, "But you know him, for he lives with you and will be in you." (John 14: 17). Notice the present and future tense here. The Holy Spirit was already with them just as he had guided God's people through their wanderings in the Old Testament. But after Jesus was crucified, raised from the dead and ascended to heaven, God the Father would send the Holy Spirit not just to be with them but to be in them. To fill them, to indwell them. This happened at the first Pentecost.

In his letter to Titus, Paul brings the cross and Pentecost together.

"But when the kindness and love of God our Saviour appeared, 5 he saved us, not because of righteous things we had done, but because of his mercy. He saved us through the washing of rebirth and renewal by the Holy Spirit, 6 whom he poured out on us generously through Jesus Christ our Saviour, 7 so that, having been justified by his grace, we might become heirs having the hope of eternal life." (Titus 3: 4-7).

"washing of rebirth and renewal by the Holy Spirit" are not two separate events but one and the same. It is the Holy Spirit who convicts us of sin, brings us to new birth, baptises us and raises us to new life, never to leave us. No longer orphans but heirs.

When a person trusts in Jesus Christ as their Lord and Saviour, the Holy Spirit comes to indwell them. He helps them to become more and more like Jesus and continue his work. In the preceding verses Jesus says,

"Very truly I tell you, whoever believes in me will do the works I have been doing, and they will do even greater things than these, because I am going to the Father. And I will do whatever you ask in my name, so that the Father may be glorified in the Son. You may ask me for anything in my name, and I will do it." (John 14: 12-14)

This is why I always end my prayers, "in the name of Jesus". Why is this important? Because what was true of the disciples is also true of us. Without the Holy Spirit to strengthen us, to encourage us, lead us, guide us and indwell us, without Him we too will not make it. No one can live a godly life without the help of the Holy Spirit. In his catechism, Martin Luther put it like this:

"I believe that I cannot by my own reason or strength believe in Jesus Christ, my Lord, or come to Him; but the Holy Ghost has called me by the Gospel, enlightened me with his gifts, sanctified and kept me in the true faith, even as He calls, gathers, enlightens and sanctifies the whole Christian Church on earth and keeps it with Jesus Christ in the one true faith . . . . "

Jesus makes three promises in these verses. First, Jesus promises he will not leave us as orphans. Second, Jesus promises that the Father will send us His Spirit to indwell us.

The promise of the Son. The promise of the Holy Spirit.

### 3. The Promise of the Father

"Whoever has my commands and keeps them is the one who loves me. The one who loves me will be loved by my Father, and I too will love them and show myself to them . . . Anyone who loves me will obey my teaching. My Father will love them, and we will come to them and make our home with them." (John 14: 21, 23)

Surely this promise must be one of the greatest and most profound in the whole Bible. Jesus promises that if we obey his teaching, God the Father and God the Son will make their home with us. In the Old Testament, the Shekinah glory of God was unapproachable, dwelling first in the tabernacle and then in the Temple. Only one person on one day of the year could enter the Holy of holies to make sacrifice for God's people. But because of the cross, because Christ atoned for our sins but dying on the cross in our place, God the Father, God the Son and God the Holy Spirit will make their home with us.

strike. Over the next five days, the fighting was fierce, but Israel drove the Arab armies out of Jerusalem and out of Israel. For the first time in nearly two millennia, Jerusalem was united and under Jewish control!

love for Israel rather than hatred for the Arabs. Undoubtedly, amongst the huge mass of people there were a handful of obnoxious rabble-rousers spewing venom, but extremists will be found in any large group of people. Not surprisingly, though, it is this tiny minority that the global media puts forth as the representatives of Israeli sentiment. What else can you expect from the Medianites?

For those of us who understand Scripture and God's great plan for Israel and the church, the reunification of Israel is one more tick on God's end times list.

We rejoice because the Lord has fulfilled His promise to His people to bring them back into the land. And we anxiously await the day when He will take the church to be with Him, then return following Jacob's trouble to an Israel that will finally be waiting to receive Him as their Messiah and Lord!



### 'VICTORY IS OUR MORAL DUTY': AMBASSADOR HUCKABEE VOWS UNWAVERING SUPPORT FOR ISRAEL IN FIRST PUBLIC SPEECH

In his first public speech in Jerusalem since taking office, U.S. Ambassador to Israel Mike Huckabee received multiple standing ovations during his address at the JNS International Policy Summit on Monday.

In his address, Huckabee praised Israel's contributions to the United States, noting, "The relationship with Israel is a two-way street. Most Americans don't realize that technologies, medical breakthroughs, and agricultural innovations that have transformed their lives came from Israel."

He then emphasized the urgency of standing with Israel, declaring, "We must not allow the world to remain silent in the face of evil. Silence empowers the oppressors and abandons the victims. We are called to speak, to


act, and to stand firmly with Israel — without apology, without hesitation."

He continued by highlighting Israel's frontline role in a broader global struggle.

"Israel is fighting the war of the free world. Its enemies are not just enemies of Israel—they are enemies of freedom, of democracy, and of human dignity. The fight that Israel wages today is the same fight that all free nations must be willing to confront tomorrow."

Huckabee concluded with a call for victory.

"Victory is not just necessary — it is our moral duty. Defeat is not an option when the stakes are the survival of a nation, the future of civilization, and the honor of standing on the right side of history. We must stand with Israel until the battle is won." (ANI/TPS)





Christian media users are a bit younger, more familyoriented, and more conservative than non-users.

The broad reach of Christian media is fueled by a diverse and dynamic audience. Compared to non-users, Christian media users tend to be younger. They're also more likely to be married, raising children, and working full-time. These users often lean politically conservative and demonstrate deeper spiritual commitment,

forming a cultural subgroup whose media habits reflect their values.





Among users who engage with both broadcast and digital sources, the demographic profile is even more youth-oriented and family-centric. ### Want to Lead Well? Ricky Dickson Says It Starts with God, Not You

NRB members recently had the exclusive opportunity to participate in a webinar titled "From Fear to Faith: Leading with Biblical Integrity in a Fallen World." The session featured insightful discussion with Ricky Dickson, retired CEO of Blue Bell Creamery and best-selling author of One Scoop at a Time and was hosted by Allie da Silva, communications strategist at NRB.

The webinar provided encouragement and practical guidance for Christian media professionals, ministry leaders, and communicators seeking to stand firm in biblical truth.

"Biblical integrity is living a life that reflects the heart of God," Dickson said, "through consistency and transparency and faithfulness. Just the fact that you're living not for yourself, but you're living a life through integrity." For Christians, Dickson said God's very heart should be evident in all areas of our lives—the decisions we make, how we carry ourselves, and the way we speak.

Dickson shared his unique story leading the beloved ice cream company, a journey he began from a small college

marketing project. He spent more than 43 years at Blue Bell, eventually retiring as president & CEO about a year ago.

Dickson shared a pivotal moment in his career that significantly tested his faith. It was during this challenge that he got a clear message from God, who told him: "I didn't bring you here for a promotion. I brought you here for My purpose."


This realization shifted his mindset from seeking advancement to instead seeking daily focus on glorifying God in his position.

Addressing the common fears faced by Christian leaders today, such as feeling inadequate, making wrong decisions, or being pressured to compromise beliefs, Dickson offered strength from what he calls his "scriptural foundation pillars." He highlighted verses that guide his approach to leadership, including Romans 12:1-2, Psalm 37:4-5, and Exodus 14:14.


Dickson emphasized that navigating cultural pressures while remaining biblically faithful can sometimes feel isolating. His advice is to "be grounded in biblical truth," know who you are, who you stand for, avoid compromise, and lead with love and responsibility.

Dickson spoke of leadership not just in terms of success or results, but as stewardship of people and the mission, drawing inspiration from the call to make disciples. This commitment to investing in others continues into his retirement, through mentoring students at universities.

"Your walk is louder than your talk," Dickson said. Authenticity and living out one's faith are crucial. For Christian communicators facing fear today, Dickson offered encouragement: "Don't give up. Don't give in." He reminded attendees not to take shortcuts or compromise principles, because "God has your back."





Why is the topic a stigma when most all of us today struggle with something that Battles our Minds and keeps us at bay.

The Harvest is ripe for a time that we can come forth with compassion and care to help the least of these with the precious love of Jesus. ### **Missouri AG Institutes Dual Age Verification for Porn Sites**

The growing movement among states to require age verification before accessing pornographic websites has reached groundbreaking heights as Missouri is set to become the first state in the nation to require dual age verification on both the site itself and the internet device accessing the site.

Last week, Missouri Attorney General Andrew Bailey (R) announced that a new rule would be issued under the state's Consumer Protection

statute stipulating that all commercial pornographic websites must verify that the age of a user of their site is, in fact, an adult over the age of 18 on both the website itself and on the user's internet-capable device. The rule also requires that porn sites immediately delete all age-related data from their sites after a user's age has been verified.

The new rule is the first of its kind in the U.S. Currently, 21 other states have passed laws requiring porn sites to verify the age of users before allowing access, but none require a dual age verification procedure.

"I want Missouri to be the safest state in the nation for children, and we'll use every tool at my disposal to make that happen," Bailey told Family Research Council President Tony Perkins during Wednesday's edition of "Washington Watch." "This rule is about protecting kids and reinforcing parental rights to determine what is appropriate for our children to be exposed to. There are smut peddlers across this country who have flooded the internet with explicit imagery and websites that are dangerous for children, quite frankly. And so, it's important that we have age verification before youth are able to access these sites. This is the strongest age verification rule in the United States of America."

Studies show that the rate at which minors are exposed to pornography is exceedingly high. One survey found that 73% of teens aged 13-17 had consumed pornography, with 15% saying they viewed porn at age 10 or younger and 54% saying they viewed it at 13 or younger. The same survey found that 52% of 13 to 17-year-olds "saw violent pornography including choking (36%), someone in pain (37%), or depictions of what appeared to be rape (19%)."

Organizations like the National Center on Sexual Exploitation (NCOSE) say they welcome laws like the new Missouri rule and encourage more states to follow suit. "We support any constitutional effort to prevent kids from accessing pornography online — whether at the website level or device level," Tori Hirsch, legal counsel for NCOSE, told The Washington Stand. "States should take a 'belt and suspenders approach' to solving this problem, age verifying at the website level, device level, and app store level."

Bailey further acknowledged that the new rule is likely to be challenged in court, but he believes it stands on firm legal ground.

"Look, there's a lot of money to be made in this industry," he pointed out. "And for too long, these people have made it way too easy for children to access these materials. ... [A] lot of people say, 'Look, freedom on the internet is important, and you shouldn't be passing a rule in one state that interferes with other states' ability or individuals passing through a state to be able to access these websites.' But ... if I go on to a website that sells firearms or ammunition, New York and California passed laws that I have to prove I'm 18 before I can access a gun website, and there's a constitutional right to keep and bear arms. And so, all we're saying is that there's got to be some kind of safeguard in place."



The rule is scheduled to be published on May 1 and will go into effect 90 days later after a comment period. "[W]e're confident in our legal authority," Bailey noted. "Our state statute provides broad authority for the Missouri Attorney General's office to promulgate rules to protect consumers in the market-place, and specifically from activities like these." He also highlighted how the new rule "prevent[s] data harvesting or online tracking" and requires search engines "to block

explicit images unless the user can provide that age verification."


"There are robust protections for the consumers and for children, and to enforce parental rights," he added.

As to whether or not the new rule will be able to be enforced against porn companies operating offshore, Bailey expressed confidence that it would.

"We have broad authority to issue investigatory subpoenas to any entity that we have reason to believe may be violating our state consumer protection law," he explained. "And we've used that in the past, and it's been upheld by the courts. ... And there are both civil and ultimately criminal penalties for violations. ... [F]oreign actors who do business in the United States of America subject themselves to the laws of the United States of America to include state Consumer Protection code."

Bailey concluded by underscoring how important protective measures against porn are for minors in light of how widespread and serious the issue has become.

"Everyone knows, based on the documentation in the public domain, the dangerous health outcomes — mental and physical, [the] inability to reach full maturity — from children being exposed to pornography, and that the age at which children have been exposed to pornography has gotten lower and lower in the past years," he lamented. "With its increased availability online, we know that the average age of exposure is 11 to 12 years old. Now that's too young.





### **Do Politicians Really Care about Due Process?**

President Trump's most recent presidential campaign promised to secure America's borders. He promised not only strict enforcement of existing immigration laws, but to deport those who had entered the country illegally under a lax Biden administration. Early in his term he has delivered on those promises aggressively. Some would say too aggressively.

In fact, his efforts to remove illegal immigrants have been the subject of virtually non-stop litigation. With Republicans in control of the White House and both houses of Congress, progressives have turned to the courts in hopes of frustrating President Trump's agenda, and a record number of federal judges have been

cooperative. Senator Ted Cruz (R-Texas) recently noted on his podcast there have been more nationwide injunctions against Trump in the first two months of his presidency than there were in the entire 20th century, with many of them involving immigration.

One of the lawsuits against the administration include a class action challenging the use of the 1798 Alien Enemies Act to deport Venezuelan gang members. Trump designated eight transnational gangs as Foreign Terrorist Organizations and believes this allows him to use the Alien Enemies Act to deport gang members as enemy combatants, a quicker process than the typical deportation process.

The case receiving the most attention involves Kilmar Abrego Garcia, a man who does not dispute his illegal presence in the country but was deported through a process the Trump administration admits was not legal. Mr. Garcia has become something of a cult figure on the Left, especially for Democrats who insist we are millimeters away from dictatorship. Upon deportation, the government of El Salvador placed him in prison. Four congressional Democrats have traveled to El Salvador to facilitate his release from prison and return to the U.S. Rep. Maxine Dexter, from Oregon, has vowed not to leave El Salvador until Mr. Garcia is returned to the United States.

The outrage over the case seems more performative than substantive. When a federal judge determined Mr. Garcia's deportation to have been done illegally, he ordered the U.S. government to facilitate his return. But that part of the order may have exceeded the judge's authority, legally and practically. Can a judge require the U.S. government to force the government of El Salvador to do something? If El Salvador does not release Mr. Garcia, is President Trump required to send a SEAL team to kidnap him?

Even if the Trump administration persuaded the government of El Salvador to return Mr. Garcia to the U.S., they would simply deport him again legally. So why all the fuss? Politics of course.

Congressional Democrats don't care more about due process now than they did when Joe Biden was canceling student loans in defiance of court rulings, but they do care about making Trump look bad. Of course, Republicans who were very concerned about Biden's refusal to follow the law during his term are less outraged over Trump's failures to abide.

It turns out, as political power changes hands, so do the talking points. When you're in power, you

talk about "results" and "the will of the people." When you're out of power, you're gravely concerned about "due process" and the consolidation of power. As a result, due process concerns are generally raised when your political opponents are doing something you fear the public will like.

But the rest of us shouldn't play that game. While politicians may be selective about their due process concerns, we should be eternally vigilant. Due process, which begins with the idea that the government must follow the law too, is what keeps us from being governed by someone's mood. It means there is not only a right thing to do, but a right way to do it. It means you can't just make allegations, you have to present evidence.

If you're never concerned about due process when people you like are in power, you're more partisan than "defender of democracy." And if you can't bring yourself to care that Kilmar Abrego Garcia has rights because you've heard he's an illegal immigrant, gangbanging wife beater — and he may be — you can't complain if someday you find yourself in a world where no one cares about your rights because someone said something bad about you.

Due process matters because our Founders recognized two Christian doctrines: sin and the image of God in each of us. The reality of sin often leads people with power to do bad things to people who have no power. The image of God in each of us means it's our responsibility to prevent that from happening because our value and our rights come from God. So, even though politicians aren't always sincere or consistent when they talk about due process, we should be.

### THINKING AND REASONING BIBLICALLY IN 2025: THE GIFT OF POWER

In a way, Christian Americans are facing the same threats to liberty that our Founders battled during the Revolutionary War time. The difference, today, is that the voices are louder and more invasive due to social media, news cycles and technology.

Thomas Paine wrote in the "Appendix to Common Sense" that "We have it in our power to begin the world over again." Webster's 1828 Dictionary defines power as "influence; that which may move the mind; as the power of arguments or persuasion."

### WHAT DOES THIS MEAN?

Every generation has the power to reclaim the liberty codified in our Constitution. In a sense, we have a 'gift of power'—influence— and the ability to impact the thinking of the next generation. They will soon be leading our nation. Yet, for them to properly direct and manage our Republic, we must educate them in the Biblical principles of limited government, free markets and individual liberty.

If we are faithful to do this, we can lean fully on the promise of the Scriptures and the effectual power of God to subdue all things to himself. According to the effectual power whereby he is able to subdue all things to himself (Phil. 3:21).

### TEACH THE CHILDREN:

- 1. Liberty is a gift, but we must be vigilant to keep it.
- We have the noblest, purest Constitution on earth which gave birth to a world where individual liberty could flourish.
- You have power, right now, to influence the culture, friends, family and our nation for good, for liberty, and for righteousness.



### The Incredible Importance of Intentional Grandparenting

Roger and Clarisse were doting grandparents and wonderful secondary caregivers for their two granddaughters. They treasured every opportunity to be involved in their grandchildren's lives—they knew their role was important.

But after attending a grandparenting study by Legacy Coalition, an evangelical ministry aimed at equipping grandparents to be disciple-makers of their grandchildren, they started to see their role differently.

"Of course, I was already a grandfather," Roger said. "In fact, I was a Christian grandfather. But it had never occurred to me to be an intentional Christian grandfather."

As he got a clearer picture of how God sees the role of grandparenting, his approach to his grandchildren began to change. "Now, every time I see my granddaughters I think about how I can influence them for Christ," he said

He started talking more with them about Christ; he prayed more with them and read Bible stories to them. Having a vision of the spiritual significance of his role as a grandfather changed everything.

Many grandparents are like Roger and Clarisse were. They find meaning through helping their children raise their families. They love their grandkids, even spoil them a little. They don't see the greater call.

### **SCRIPTURE'S VIEW OF GRANDPARENTING**

My wife, Diane, and I became convinced of this greater call a few years ago. It started with "seeing with new eyes" a familiar passage of Scripture, Deuteronomy 4:9. In fact, it started with seeing the little word and.

"We must desire that a generation ... will follow God. ... It must be a strong passion and a vision that guides our talk and activities with our grandchildren."

Because of that single word, Diane and I moved—for the specific purpose of fulfilling the command that followed it. The verse says, "Teach them to your children and your grandchildren" (NKJV). We realized that we were to teach two generations, not just one. We were to be spiritual influencers. And, we knew it would be easier to fulfill that command from nearby than from 1,800 miles away.

Moving isn't the point: it may not be necessary, desirable or even possible for you. Seeing what Scripture has to say and obeying it is the point.

And whether it is through the simple command in Deuteronomy 4:9, or the many passages that use the phrase "generation to generation," the active role of a grandparent is a pattern regularly implied in God's Word.

Psalm 78:5-7 spells out the multigenerational vision that God wants grandparents to think and act on: "He commanded our ancestors to teach their children, so the next generation would know them, even the children yet to be born, and they in turn would tell their children. Then they would put their trust in God and would not forget his deeds but would keep his commands" (NIV).

Did you see that? According to Deuteronomy, we are to teach two generations, but according to this passage, we are to think four! Let's



put ourselves in the role of the "ancestors": we (generation one) are to teach our children (generation two) about the things of God so the grandchildren not yet born (three) would know them, and they in turn will tell their children (four). We must desire that a generation beyond the one not yet born will follow God. More than a desire, it must be a strong passion and a vision that guides our talk and activities with our grandchildren.

### THE INCREDIBLE POTENTIAL FOR DISCIPLESHIP

Grandparent, are you aware of your power for influence? You are second only to the parents in your potential to impact your grand-children spiritually.

Grandma, you have much more potential for influence than a Sunday school teacher. My children's ministry friends tell me the average child attends church 1.3 to two times a month. That means a Sunday school teacher will see an individual child for only 15 to 25 hours in a given year. Grandpa, you have so much more to offer: your unconditional love for your grandchild, your seasoned perspective, and your willingness to spend time with them make you an ideal disciplemaker. Are you getting the picture?

Of course, potential influence doesn't mean there is automatic impact. There are so many barriers to influencing grandkids spiritually. In just our small circle of friends, Janet has a granddaughter who lives in Sweden. Bill and Teresa's grandkids live with an estranged daughter-in-law. Tina is a single grandma on a limited income, and the "other grandparents" are wealthy and shower expensive gifts on her grandkids. Pete and Barb's son and family are into sports, and spiritual things are not important to them. Winnie's daughter has walked away from her Christian faith and converted to Buddhism.

So, yes, there are many obstacles. But the potential for impact is still there. Roger and Clarisse weren't living up to their potential, even though there were no barriers.

How about you? Could you "up your game?" As you think about the importance of your role, could you connect with your teenage grandkids more frequently? Could you read Bible stories to your adorable toddlers? Could you tell your grandkids your faith journey? Could you devote more time to praying for their salvation?

It's important. It's really important. Why don't you start today?

### Freedom Is Gained Inch by Inch

Religious freedom is seldom handed to the passive; it is claimed by those who exercise it even when a hostile culture says they may not. That reality came home to me this week as two very different arenas - Jerusalem's Temple Mount and the marble halls of the U.S. Supreme Court. In both instances, they posed the same enduring question: Will people of faith fight for the liberties our Creator endowed, or will they surrender them to bureaucrats and bullies?

While the Supreme Court in Washington, D.C. debated whether Oklahoma may authorize St. Isidore of Seville Catholic Virtual School for public funding, I stood on the Temple Mount with Rabbi Yehudah Glick. Rabbi Glick has been arrested scores of times for the "crime" of praying aloud at Judaism's holiest site. Why would a whispered psalm be treated like a felony?

The answer begins with geography and history. The Mount lies inside the territory diplomats still call the "West Bank," a military ceasefire line drawn in 1949 that every participant agreed was never meant to become a border. Yet that dotted line hardened into dogma for half a century of two-state "solution" proposals. Even after Israel reunited Jerusalem during the 1967 Six-Day War, international pressure compelled the Jewish state to place daily control of the Mount in the hands of a Jordanian Islamic trust. That arrangement grants Muslims unrestricted worship while permitting Jews only silent, time-limited visits — no Bibles, no Torah scrolls, no audible prayer.

Incremental change, however, happens when courageous souls test the limits. Because of Rabbi Glick's persistence, Jews today may at least ascend the Mount during restricted hours and - since last August — kneel and whisper brief prayers in a small area along the eastern wall. One inch of freedom, once claimed, becomes the platform for the next yard. His tenacity reminds us that history bends toward liberty only when principled people lean hard against its hinges.

Rabbi Glick has paid dearly for that inch: repeated arrests, social ostracism, and even a failed assassination attempt. Yet instead of retreating, he enlarged the space for everyone's freedom by exercising the sliver he possessed — proving that the defense of conscience always begins with the courageous use of conscience.



That vignette previews what's at stake in St. Isidore of Seville Catholic Virtual School v. Oklahoma. Opponents chant the tired mantra of "separation of church and state," insisting that any institution touching public funds must muzzle its faith. Governor Kevin Stitt (R) and State Superintendent Ryan Walters (R) are rightly defending their charter statute as neutral toward religion: if secular innovators can design tuition-free online schools, so can Catholics, Jews, evangelical Christians, and others. A favorable ruling would ripple through the 45 other states with charter school laws, broadening educational choice and rooting religious expression more firmly in the public

The lesson from Rabbi Glick's quiet prayer is clear: Use the liberty you still possess, however small, to expand the liberty you lack. If Oklahomans prevail, parents across America will gain the right to choose schools that reinforce rather than undermine their deepest convictions - fortifying civil society, renewing our covenantal heritage, and handing a sturdier, freer republic to our children and grandchildren.


